



The final phase of collapse of the USA and the pluto-imperialist reset has just begun.

As it was sadly foreseeable, the pseudo-pandemic of Covid19 has so far managed to temporarily divert the attention of the global public away from its essential threat, which is, in this case, a global and disruptive societal engineering operation, including the establishment of a new international cryptocurrency to replace the US Dollar, and above all, inducing in the background a related major political and economic reorganization, which can end very badly. Because its structural and conjunctural obstacles have become prohibitive.

In particular because a strong Eastern inter-State coalition wants to prevent the organizers of this operation from further abusing the various victim populations, against the human general interest. This made possible to publicly reveal on the one hand the illegitimate activity of a cartel of big banks, financial funds, industrial corporations, and various other predatory organizations, led by western pluto-imperialists, dominant but declining. While, on the other hand, there is an increasingly powerful association of Eastern banks and public currencies, coordinated around the Chinese Yuan, offering solutions of legitimacy and international law, opposed to the solutions of lucrative technocratic dictatorship concocted by the pluto-imperialists of the West.

Technically, since the new global economic trend favours the rise of cryptocurrencies, several banks and online financial platforms (including Paypal) have reaffirmed at the end of September 2020 to be open to the cryptocurrencies of the future. But China, which had anticipated this trend, did even better by offering worldwide a crypto-Yuan, successfully tested on the Chinese domestic market, guaranteed by gold reserves and by public economic fundamentals not fictitious, all of which have already earned the trust of its most strategic trading partners.



This resistant partnership ensures that Western pluto-imperialists do not try to fraudulently eclipse the new Chinese electronic cryptocurrency, by manipulation of the IMF and its possible crypto-SDR, supposedly guaranteed by gold them too, but this in order to increase the value of these SDRs by a proportion of crypto-USD (and Euros) artificially overshadowed. The Asian (especially Chinese) stock exchanges have taken precautions to be able to freely rate and change gold into Yuan, and maintain a competitive lead for the crypto-Yuan.

For their part, in order not to be prevented by the populations they manipulate, the Western pluto-imperialists persist in imposing on them at all costs the large illegitimate reset provided for, at least in their zone of influence, by exploiting the critical period of societal stress they caused. The ruinous pseudo-pandemic of the Covid19 is therefore likely to be prolonged, and aggravated by an artificial clash of civilizations, even more stressful, involving an instrumentalization of Western historical judeo-Christians springs, put under pressure and then released both against cultural neo-Marxism and against Islam, the two scarecrows most opportunely usable.

All this will cause a problematic Western strategic readaptation. Because a prognosis of societal recovery of the USA being irremediably pessimistic, if in addition there is a related failure of the US-Dollar revalorization in the crypto-SDR of the IMF, the European Union will be pushed by necessity to regain both its autonomy and the vacant Western leadership, but without having enough means to achieve it.

It will be able in particular to create a digital crypto-Euro (already announced by the ECB) that can be revalued in the IMF's SDR basket, to compensate for the collapse of the US dollar, but this will not guarantee the release of the prevented big reset, nor hyper-inflation. This will only fuel a forward flight into adventurism. This has begun, since with the support of some of the main other decision-makers in the European Union, the French President has already initiated a process of geopolitical resurgence of Europe, ostensibly on a voluntary way, starting with targeting an old common adversary, Turkey, and the Islamic terrorism it helps in several countries, including in Europe. In response, Pakistan has positioned itself in support of Turkey.

While several high-level political technocrats in place will seek to solidarize the European Union willy-nilly in a crusade against such an opponent, pluto-imperialist decision-makers will probably also urge them to get rid of their "useful idiots" Ecolo-leftists, who could disrupt both this anti-Islamic crusade, and above all, an authoritarian takeover of the populations. Until then, environmental leftists had been manipulated (successfully) to undermine traditional protective social structures everywhere, and also to promote the most possible corrosive and demanding Islamic activity, fueled by strong Muslim immigration, mainly ghettoized in Europe.

It was a dupe's deal anyway. Because given its endemic anti-Western opposition, this immigrant Muslim community has always been potentially antagonist against the immoral ecolo-leftists it despises whatever is the received help, and it can be used to attack them in priority. From there, an Islamic threat both internal and external may justify in the West a security reinforcement involving civil protection measures harder than those temporarily justifiable by Covid19. But there is no guarantee that the current fragile European interstate structure can long manage an explosion of both internal and external violence, in addition to its problems of economic contraction and monetary failure, and it will therefore not be able to achieve the objectives of the pluto-imperialist project



The United States, on its side, follows a rather similar parallel way, where the green-leftists and the aggressive minorities have become dangerous internal enemies against which a traditional majority will be able to appropriately recompose itself, but without any new illegitimate state superstructure. Because the state structures corrupted by the pluto-imperialists, who govern only in appearance under the authority of "politically correct" technocrats, have become fundamental enemies of the resistant popular legitimacy, in many countries.

In these conditions, the societal chaos unleashed will follow its own random dynamic, where each one will temporarily become the enemy of one or more others, and where social violence at the same time multifactorial, cumulable, and self-sufficient, will finally redistribute the powers, especially since the Western pluto-imperialists and their stooges will lose theirs.

They will lose them in particular because the logical outcome of such chaos is that as destructions will go along, the illegitimate interests involved will become mutually incompatible and conflicting, between on the one hand the weakened main globalist pluto-imperialist lobbies, and on the other hand their accomplice auxiliaries locally involved, such as some high technocrats and politicians, some high financial and economic leaders, and some ideological leaders (notably Zionists), until, freed from the constraints which hindered it, the majority legitimacy of each population can finally express itself and reorganize itself sufficiently in the general interest, probably with the help of the main Eastern nations who will know not to be dragged into chaos.

The US entered since November 3rd 2020 its first concrete phase of internal interdestruction, beginning its most confrontational presidential electoral process since its creation in the 18th century. Whatever is the official result of the vote, and the chosen winner, and the internal partisan clashes that will ensue, in one way or another, the collapse of the US will continue until this former hegemonic empire is reduced to a mere ruined regional power. But before reaching this point, will its leaders prefer a violent collective suicide in one or more wars, internal and/or external, that will shoot the coup de grâce anyway to the US? We'll probably get the answer soon.
